February 17, 2021, Helms College was awarded 1,077,604 from the federal Coronavirus Response and Relief Supplemental Appropriations Act, or HEERF II - CRRSAA. \$301,498 was allocated to Student Emergency Funds. Unlike the CARES Act, CRRSAA requires institutions prioritize students with exceptional need, such as students who receive Pell Grants, in awarding financial aid grants to students.

As of June 7, 2021, a total of 134 pell eligible students received HEERF II Emergency Financial Aid Grant funding.

The total amount of HEERF II Emergency Financial Aid Grants distributed to students was \$151,000.

The amount of funds remaining for disbursement is \$150,498.
